2. All accepted applicants must obtain the necessary forms, licenses, permits, certificates and/or inspections from the [Gallatin City-County Health Department](#) or from the State of Montana.
3. Applications are accepted on an ongoing basis throughout the market season. However vendors who are pre-paying for the entire 2020-2021 season must submit their applications and payment **by September 1**.
4. Any application submitted after September 1 requires a \$10 application fee. There is no fee required for applications submitted before September 1.
